

Andelka Marković (1975) diplomirala je na Pravnom fakultetu Univerziteta u Beogradu. Usavršavala se na stručnim programima iz oblasti ljudskih prava u Grčkoj, SAD i u Švedskoj. Radno iskustvo stekla je u nevladinom sektoru u Srbiji i u Crnoj Gori.

Više od 17 godina saradivala je na projektima koje su u Srbiji sprovodili Program Ujedinjenih nacija za razvoj (UNDP), Savet Evrope, OEBS, Međunarodni centar za razvoj migracione politike (ICMPD). Učestvovala je u aktivnostima niza izbornih posmatračkih misija (OSCE ODIHR EOM), a potom i u projektima konsultantskih kompanija.

Od 1999. godine i angažmana u organizaciji *Centro Regionale d'Intervento per la Cooperazione* koja je delovala u Crnoj Gori, aktivno je doprinosila inicijativama i projektima u vezi sa distribucijom humanitarne pomoći i u vezi sa ostvarivanjem radnih i socijalnih prava izbeglica i raseljenih lica sa područja bivše SFRJ, sve do 2004. godine..

Ispred Beogradskog centra za ljudska prava radila je na unapređenju sprovođenja Zakona o slobodnom pristupu informacijama od javnog značaja u Republici Srbiji, kao član neformalne koalicije NVO za slobodan pristup informacijama i kao koordinator edukativnih programa u ovoj oblasti.

Urednica je i koautorka više alternativnih izveštaja o sprovođenju strateških antikorupcijskih dokumenata, kao i Izveštaja o samoproceni integriteta organa javne vlasti koji je objavila Agencije za borbu protiv korupcije Republike Srbije.

Objavila je veći broj članaka, eseja i koautor je nekoliko izdanja u oblasti borbe protiv trgovine ljudima. Radovi su objavljivani u Srbiji, Bosni i Hercegovini, Grčkoj, Sloveniji.

Osnivačica je i urednica regionalnog portala protivtrgovineljudima.org

Koautorka je niza alternativnih izveštaja o stanju ljudskih prava u SR Jugoslaviji, u Državnoj zajednici Srbiji i Crnoj Gori i u Republici Srbiji.

Raspolaže iskustvom u praćenju suđenja u predmetima pred Odeljenjem za ratne zločine Višeg suda u Beogradu i u predmetima pred Posebnim odeljenjem za organizovani kriminal Višeg suda u Beogradu.

Bila je član Centra za odbranu ljudskih prava u Atini (Grčka) i Udruženja za međunarodno pravo (Srbija).

Andjelka Markovic (1975) graduated from the University of Belgrade School of Law and holds a law graduate – master degree. She attended specialized programs on human rights in Greece, in USA and in Sweden.

A vast number of engagements in civil sector in Serbia and in Montenegro have shaped her skills and experience. Since 1999, she has been involved in projects implemented by the United Nations Development Programme (UNDP), the Council of Europe, the OSCE, the International Centre for Migration Policy Development (ICMPD), as well as in activities of the election observation missions (OSCE ODIHR EOM) and of consulting companies in Serbia.

Since 1999 and her engagement in *Centro Regionale d'Intervento per la Cooperazione* – a non-profit that provided displaced persons and refugees in Montenegro with humanitarian aid – Andjelka has been actively contributing to humanitarian assistance initiatives and assisted refugees and internally displaced persons in achieving enjoyment of labour or social rights they were entitled to, until 2004.

On behalf of the Belgrade Centre for Human Rights - as a member of the informal coalition of NGOs and coordinator of BCHR FOIA educational programs - she advocated the improvement of implementation of the Law on Free Access to Information of Public Importance in Serbia.

Andjelka co-authored several alternative reports on implementation of strategic anti-corruption documents, as well as the Public Authorities' Integrity Self-Assessment Report, published by the Anti-Corruption Agency of the Republic of Serbia.

She wrote a number of articles, essays and co-authored several publications on combating trafficking in human beings. Her writings have been published in Serbia, Bosnia and Herzegovina, in Greece and in Slovenia. Andjelka founded the regional web portal protivtrgovineljudima.org (“Against human trafficking”).

She co-authored a series of alternative reports on human rights in the Federal Republic of Yugoslavia, in the State Union of Serbia and Montenegro and in the Republic of Serbia.

She has a multiyear experience in monitoring of trials held before the War Crimes Chamber of the Higher Court in Belgrade and trials held before the Special Department for Organized Crime of the Higher Court in Belgrade.

Andjelka was a member of the Human Rights Defence Centre in Athens (Greece) and of the International Law Association (Serbia).

She speaks English, Italian and Russian.
